Destruction Methods

Physical Destruction:

Shredding or burning/melting in order to completely destroy the media itself

Firmware Based Security Erase or Purge:

Hardware-based solutions connect directly to the hard drive and implement an erasure command that erases data but allows the drive to be redeployed. Many hardware solutions use the Secure Erase protocol developed by the NSA for ATA/SATA harddrives.

Software Overwrite:

Software based data destruction deploys a special application to write patterns of meaningless data (a combination of 1s and 0s) onto the drives and LTO or 3592 tape, usually requiring several passes. The Department of Defense standard requires 3 levels of overwriting.

Hard drive & Tape Degaussing: Deploys a powerful magnetic field that destroy all magnetically recorded data. High capacity tape using servo tracks are rendered void of data and cannot be read even using forensic procedures.
